#### 第 MPF(S)-P(P)號表格、註釋及本〈指南〉的用詞解釋 : Explanation of terms used in Form MPF(S)-P(P), the Explanatory Notes and this Guide:

- (a) 「供款帳戶」一與《規例》第 2 條所載的供款帳戶具有相同含義。一般是指強積金計劃下主要用以接收僱主為僱員所作出以及代表僱員所作出的強積金供款(包括僱主及僱員部分)的帳戶。供款帳戶亦包括自僱人士在新計劃下主要用以接收其在自僱期間所作出的強積金供款的帳戶。"Contribution account" has the same meaning as in section 2 of the Regulation. Generally, it is an account in an MPF scheme which is mainly used to receive MPF contributions (both employer and employee portions) made by an employer for an employee and on behalf of the employee.
